## Manti City Aquatic Center Rules and Regulations

- Cancellations must be made 5 working days prior to rental date to receive a refund of the rental fee. If you want to change the rental date, this must also be done 5 working days prior to rental date.
- This facility is a drug, alcohol, and smoke free, these things are not allowed on the premises.
- Mature and responsible behavior is required.
- The life guards on duty are there for your safety and all rules must be followed.
- Group or family leaders must properly supervise their group and maintain orderly behavior at all times. Group leaders and participants will cooperate with facility staff to ensure compliance with rules and policies.
- Group and family leaders will not assume that the presence of lifeguards or other host facility staff in any way relieves them of responsibility.
- Group and family leaders agree that all participants of their group or family will follow ALL facility rules and guidelines. Any group or participant not following these rules and guidelines will have their activity terminated immediately with no monetary refund.
- All areas must be left clean of trash and personal belongings before leaving the facility.
- No group or family is allowed extra rental time without paying in advance. All groups must arrive on time and must not enter the facility until pool patrons, or the previous party has been cleared out.
