

## **Notice of Election**

### **2018 Regular General Election**

I, Sandy Neill, Sanpete County Clerk, pursuant to provisions of Utah Code, 20A-5-101(2), do hereby give notice to the public that candidates are to be elected for the following offices at the upcoming General Election to be held on Tuesday, November 6, 2018. The Declaration of Candidacy filing period for qualified political party candidates and local school board candidates begins on Friday, March 9, 2018 and ends at 5:00 p.m., Thursday, March 15, 2018. The Declaration of Candidacy filing period for judges of a court of record begins Monday, July 2, 2018 and ends at 5:00 p.m., Monday, July 16, 2018. The Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Tuesday, January 2, 2018 and ends on Thursday, March 15, 2018 at 5:00 p.m. Candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.

#### **I. Federal**

- A. U.S. Senate. One (1) Senator for a six (6) year term.
- B. U.S. House of Representatives. One (1) Representative from the Second and Fourth District for a two (2) year term.
  - 1. The Second Congressional District consists of Beaver, part of Davis, Garfield, Iron, part of Juab, Kane, Millard, Piute, part of Salt Lake, part of Sanpete, Sevier, Tooele, Washington, and Wayne Counties
  - 2. The Fourth Congressional District consists of Juab, part of Salt Lake, part of Sanpete, and part of Utah Counties

#### **II. State**

- A. State Executive. The Attorney General position will be elected for a two year term.
- B. House of Representatives. One member of the Utah House of Representatives from District fifty-eight (58) and one from District seventy (70) for a two (2) year term.
  - 1. District fifty-eight (58), Juab and Sanpete Counties.
  - 2. District seventy (70), Emery, Grand, Sanpete, and Sevier Counties.
- C. State Board of Education. One member for a four (4) year term.
  - 1. District fourteen (14), Beaver, Carbon, Emery, Garfield, Grand, Kane, Millard, Piute, San Juan, Sanpete, Sevier, Utah, and Wayne Counties.

#### **III. Sanpete County**

- A. County Commissioner. Two members for four (4) year terms.
- B. County Attorney. One for a four (4) year term.
- C. County Auditor. One for a four (4) year term.
- D. County Clerk. One for a four (4) year term.
- E. County Sheriff. One for a four (4) year term.

#### IV. Local School Board

- A. One member for a four (4) year term from each of the following local school districts.
  - 1. North Sanpete School District #four (4), Consists of Fountain Green:M, Wales:M, NS:U
  - 2. North Sanpete School District #five (5), Consists of Fairview:M and Fairview:U
  - 3. South Sanpete School District #one (1), Consists of Manti:M and Manti:U
  - 4. South Sanpete School District #four (4), Consists of Ephraim:2M
  - 5. South Sanpete School District #five (5), Consists of Ephraim 1M: and Ephraim:U

#### V. Judicial

- A. Supreme Court. There will be an unopposed retention election for one (1) Supreme Court Justice provided that the incumbent whose term is expiring files during the filing period.
- B. Court of Appeals. There will be an unopposed retention election for one (1) Court of Appeals Judge provided that the incumbent whose term is expiring files during the filing period.
- C. District Court. There will be a retention election for one (1) District Court Judge in the Sixth District provided that the incumbent whose term is expiring files during the filing period.

#### VII. Master Ballot Position List

In accordance with Utah Code Annotated §20A-6-305(2), the master ballot position list will be established within 30 days after the March 15, 2018 candidate filing deadline.

A person seeking to become a candidate for any elective office for the 2018 election shall file a declaration of candidacy with the following persons:

Sanpete County Clerk: Sanpete County Offices and Local School Board Offices

Lt. Governor or County Clerk: Multi County State Legislative Offices, State School Board Offices and Court of Record Retention Offices.

Lt. Governor: Congressional Offices and Utah Constitutional Offices.
