ORDINANCE NO. 12-19-00

AMENDMENT TO COUNTY ORDINANCE PROVIDING FOR LICENSING OF BUSINESSES IN SANPETE COUNTY

The Board of County Commissioners of Sanpete County, Utah, hereby ordains as follows:
The County Ordinance regulating the licensing of a businesses in Sanpete County as recorded in Ordinance Record Book of Sanpete County, pages 162 and 163, dated February 10, 1969, is hereby amended as follows:

It shall be unlawful for any person, firm or corporation to engage in or conduct, in Sanpete County, Utah, outside the geographical limits of incorporated towns and cities any business or pursuit hereinafter mentioned without having first obtained a license, and having paid the license fee therefore, as hereinafter provided, for the several businesses and pursuits hereinafter mentioned, to-wit:

- A. <u>LARGE SCALE WHOLESALE AND RETAIL SALES</u> Any person, firm or corporation dealing directly or indirectly in any manner in motor vehicles, petroleum, mining machinery and equipment and all other types of machinery and equipment, steel distribution or supply, and any other type of heavy industrial or commercial sales of any type or description and not otherwise specifically licensed by this ordinance for each place of business operated shall be required to pay a license fee of \$100.00.
- B. <u>SMALL SCALE WHOLESALE AND RETAIL SALES</u> Any person, firm or corporation dealing directly or indirectly in any manner in appliances of any kind, hardware, chemicals, milk, food, permanent fruit and vegetables sales, restaurants, fast food sales, coffee houses, bakery products, groceries, meat, fish, poultry, dry goods, clothing, sporting goods, notions, drugs, jewelry, soft drinks, nurseries, flowers, furniture and real estate or any other good, wares or merchandise, of any kind or description and not otherwise specifically licensed by the ordinance, for each place of business operated shall be required to pay a license fee of \$50.00. Those selling agricultural products which are grown in Sanpete County, will not be required to purchase a business license.
- C. <u>LARGE SCALE INDUSTRIAL BUSINESS</u> All businesses dealing with the manufacturing, processing, fabrication of goods, electrical generating plants, coal loading and washing and storage facilities, refineries, and other large scale industries shall pay \$100.00 per year.
- D. <u>SMALL SCALE INDUSTRIAL BUSINESS</u> All renderies, packing plants, wrecking and salvage, and other smaller scale industrial businesses shall pay \$50.00 per year.
- E. <u>PROFESSIONAL BUSINESSES</u> All attorneys, auctioneers, insurance brokers, physicians, dentists, veterinarians, accountants, engineers, surveyors, morticians and all other professions not herein stated shall pay \$75.00 per year.
- F. HOSPITALS All hospitals shall be required to pay \$50.00 per year.
- G. MEDICAL CLINICS All medical clinics shall be required to pay \$50.00.

- H. <u>RECREATIONAL BUSINESSES</u> All billiard halls, bowling alleys, dance halls and studios, resorts, skating, rinks, swimming pools, theaters, amusement centers, recreation centers, spa's, hunting lodges, fishing camps, and all other recreational businesses not herein stated shall pay \$75.00 per year.
- I. <u>RENTAL BUSINESS</u> (Storage) Warehouses shall pay \$50.00 per year. Storage buildings shall pay \$1.00 per unit not to exceed \$75.00. Cold storage shall pay \$50.00 per year.
- J. <u>MOTELS, HOTELS, MOBILE HOME PARKS</u> All motels, hotels, and mobile home parks shall pay \$50.00.
- K. <u>RECREATIONAL VEHICLE COURTS</u> All recreational vehicle courts shall pay \$50.00 per year.
- L. <u>APARTMENT AND BOARD HOUSES</u> All apartment houses (3 apartments or more) and office buildings which rent or lease space shall pay \$50.00 per year.
- M. <u>EQUIPMENT RENTAL</u> All equipment rental businesses shall pay \$50.00 per year.
- N. <u>FINANCIAL BUSINESSES</u> All banks, savings and loan, credit unions, etc. and all other financial businesses not herein stated shall pay \$50.00 per year.
- O. <u>SERVICE RELATED BUSINESSES AND TRADES</u> All repair and service facilities, dry cleaning, delivery, dog kennels, printing, junk collecting, laundry supply, barbers, beauty parlors, taxi's, welding, upholstery, vulcanizing, garbage collection, and all other services not herein stated shall pay \$50.00 per year.
- P. <u>CONTRACTORS</u> All general contractors and contractors for plumbing, heating, and air conditioning, electrical, carpentry, painting, cement, construction, road surfacing, grading and all other contractors not herein stated shall pay \$50.00 per year. A copy of the current Utah State Contractors license must accompany the application for the county business license.
- Q. <u>TRUCKING BUSINESSES</u> All trucking businesses related to oil hauling, motor freight, and other trucking not herein listed shall pay \$50.00 plus \$10.00 per truck, not to exceed \$100.00 dollars per year.
- R. <u>TEMPORARY USES</u> All temporary uses listed on this page shall obtain a business license for the following fee. Each person obtaining a license shall first show proof of landowner permission for the use of the site on which the temporary use will be under taken. Temporary meat and fish sales-----\$50.00 Mobile sales, shows, exhibitions-----\$50.00
- S. <u>MINING</u> Oil and gas exploration, drilling projects, and other mines not herein stated shall pay \$200.00 per year.

- T. <u>SMALL SCALE MINING OPERATIONS</u> Small scale sand and gravel operations shall pay \$50.00 per year.
- U. <u>BUSINESSES OPERATED AT HOME</u> All businesses conducted from the home of the operator which have gross receipts of \$5,000.00 or more per year shall pay \$50.00. Such business having gross receipts of less than \$5,000.00 per year shall pay \$25.00.
- V. <u>LIQUOR SALES</u> A & B liquor shall pay \$200.00 per year, and C liquor shall pay \$300.00 per year.

It shall be the duty of the County Clerk by and with the approval of the Board of Commissioners to fix and determine the amount of any license fee for any business or undertaking not herein above mentioned; provided that such license shall not be less than \$25.00 and not more than \$200.00 per year. It shall be unlawful for any person to conduct any business not herein before listed without paying the license fee as assessed by the County Clerk and Board of Commissioners as provided herein.

The County Commission, upon finding that any person, firm or corporation or any employee of said firm or corporation licensed under this ordinance has violated any Utah State Law or any Sanpete County ordinance, or that false information has been given in the license application or that the business is being operated in a manner detrimental to the public hearing on the revocation. The business license fee shall not be refunded.

This ordinance shall become effective January 1, 2001. ADOPTED THIS 19TH DAY OF DECEMBER, 2000.
